7. New Business:

- A. Monica Buchanan Lee/Scott County WIOA Adult Dislocated Worker Program spoke on the services provided by her office. Retraining, youth programs for ages 14-24, help in overcoming barriers such as having been in jail, tuition for Vo-Tech programs, MECC welding, HVAC, power lineman classes, mileage, vehicles, up to 500 hrs. paid for youth workers, business services/training, resume/interview skills. Lee County is underserved.
- B. **DBSW Kids in the Creek-** October 1st request to use Leeman Field and the river area again. Terry Pope made the Motion to allow this project. Jill Carson seconded the Motion. Roll call vote as follows:

- C. Wreaths Across America, PG Woman's Club-Ruth Gilliam detailed the project undertaken by the Club which is sponsoring Mountain Home Cemetery in TN, finding a list of 43 Lee County veterans buried there. Further study shows more could be from Lee County having used addresses such as Duffield and Big Stone Gap as the county lies in those areas. The program began with a donation of leftover wreaths from a wreath company to the National Cemetery and now exceeds what can be donated. A 501C3 organization was formed with the mission of Remember, Honor, Teach. PGWC is trying to raise enough to place a wreath on every Lee Countian's grave at Mountain Home. Donations for one wreath are \$15
- D. **Bridge Naming**-Faye Bocock, PG Woman's Club followed by stating that the Club has been asked to adopt Cecil Frye Cemetery to further the veteran recognition. She requested that the bridge at Leeman Field over the river be named in memory of Lonnie Evans and Scott

Delph who lost their lives in Vietnam. Terry Pope asked if they knew of a Goforth from Ewing area and Greg invited them to look at some history contained at the Lee County Genealogy Society about some war casualties. Jill suggested using WCYB to recognize some.

- E. Outdoor Classroom grant-Keith explained that he had partnered with Amy Byington from Virginia Tech's Extension Office on an outdoor classroom grant in which \$10k was awarded. He included pictures of what it could look like on the greenway near the river.
- F. Virginia Department of Historic Resources-Keith shared his meeting with this department on establishing an historic district in town, which would include 50+ year old buildings potentially from the First Baptist Church down to the community center, across W Morgan to the stores there, down N Kentucky to Pullin Ink, across that street to Davis Transmission on N Main and across W Morgan to Dr. Robinson (old bus station) and up to PV News and on up to Edward-Jones office. Tax incentives for businesses locating in those buildings can be 25%. There is a \$6-8K application fee. Cost share may pay 50% of fee. The town would mneed a Historic Commission as an advisory board and the participant has to follow their advice for 5 years. Jill added that the Cultural Center application process is nearly complete. Terry added it is a good marketing tool to have and made a Motion to apply for the designation. Jill Carson seconded the Motion. Roll call vote as follows:

- B. Brian Skidmore reported the Main Street parking lot work is complete and turned out well. Mattern & Craig will start I & I work near the end of October/early November for 30 days. Discussion, consideration, or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public officers, appointees, or employees of any public body; and evaluation of performance of departments or schools of public institutions of higher education where such evaluation will necessarily involve discussion of the performance of specific individuals. Any teacher shall be permitted to be present during a closed meeting in which there is a discussion or consideration of a disciplinary matter that involves the teacher and some student and the student involved in the matter is present, provided the teacher makes a written request to be present to the presiding officer of the appropriate board. Nothing in this subdivision, however, shall be construed to authorize a closed meeting by a local governing body or an elected school board to discuss compensation matters that affect the membership of such body or board collectively.

§ 2.2-3711(A)(3): Acquisition & disposition of property. Provides an exemption for:

Discussion or consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body.

Virginia Code Section 2.2-3711(A)(6) Discussion or consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the governmental unit would be adversely affected.

Virginia Code Section 2.2-3711(A)(7) Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the public body. For the purposes of this subdivision, "probable litigation" means litigation that has been specifically threatened or on which the public body or its legal counsel has a reasonable basis to believe will be commenced by or against a
