- 6. Unfinished business:
 - A. Bridge Naming At the September regular meeting, Faye Bocock, Pennington Gap Woman's Club had proposed naming Leeman Field bridge for Vietnam veterans Scott Delph and Lonnie Evans. She was asked to find more information and make sure everyone would be recognized. Gary McElyea prefers the bridge be named for Pennington Gap citizens and would like a marker somewhere listing all veterans of Pennington. Greenway Outdoor Classroom Amy Byington and Keith have looked at creating an amphitheater effect with stackable concrete stones from the plant next door with a location on the greenway between the extension office and school. - **C.** Keith reported the second round of Shuttered Venue funding has been received bringing the total to just over \$34k. Marshall Tucker was a sellout. Mattern & Craig task management structural grant is signed. Hill Studios applied for downtown grant.
- 10. **Sidewalk Safety Project-**Second phase of sidewalk grant application will be for Edwards Street to the hospital. A cave found in current construction was not a concern to the VDOT representative. The contractor is filling and laying line and it may be on the VDOT right of way which will be covered by VDOT work. Elk Knob construction would like to further discuss the property the town purchased there. An infrastructure bill recently introduced may speed up phases 2 & 3. Keith is currently certifying as a local VDOT representative for the projects.

- 13. **Closed session** At 3:42 PM, Terry Pope made a Motion to go into executive session pursuant to: § 2.2-3711(A)(1): Personnel. Provides an exemption for:

Discussion, consideration, or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public officers, appointees, or employees of any public body; and evaluation of performance of departments or schools of public institutions of higher education where such evaluation will necessarily involve discussion of the performance of specific individuals. Any teacher shall be permitted to be present during a closed meeting in which there is a discussion or consideration of a disciplinary matter that involves the teacher and some student and the student involved in the matter is present, provided the teacher makes a written request to be present to the presiding officer of the appropriate board. Nothing in this subdivision, however, shall be construed to authorize a closed meeting by a local governing body or an elected school board to discuss compensation matters that affect the membership of such body or board collectively.

§ 2.2-3711(A)(3): Acquisition & disposition of property. Provides an exemption for:

Discussion or consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body.

Virginia Code Section 2.2-3711(A)(6) Discussion or consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the governmental unit would be adversely affected.

Virginia Code Section 2.2-3711(A)(7) Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the public body. For the purposes of this subdivision, "probable litigation" means litigation that has been specifically threatened or on which the public body or its legal counsel has a reasonable basis to believe will be commenced by or against a known party. Nothing in this subdivision shall be construed to permit the closure of a meeting merely because an attorney representing the public body is in attendance or is consulted on a matter.
