 Tammy Franklin reported the final day of ice skating was January 15 and the first season was considered successful. The rink will return in July for a few hours daily along with the pool. Terry questioned volunteer help and whether there are ideas on attracting more help for so many activities during the holidays. Tammy will also think of ideas before next season.

11. Projects

- A. ARC Business Center/Conference Center-Keith presented his plan to VCEDA who approves of the project and will have some funding for both buildings. Rural Development has agreed upfront to \$100k. He will pick up the brochure of the project from Hill Studios on his way to Richmond to promote the project further.
- **B.** Industrial Revitalization Fund ARPA Grant Application- Kickoff will be February 1, contract signing for \$850k and then start architectural drawings of which we will owe \$80k. Two applications were submitted, a radio station and dessert shop, however the latter has backed out. Keith would like to replace it with a meals tax opportunity. Commitment letters are needed for the Creech building, which is part 2 after 15 months to finish Bailey-Robbins. Once one commits, we can design and build to fit. We are approved for \$150k for a roof on Creech building and we will do the tear off.

- **C. Historic Designation**-A Town Hall meeting will be held in February to notify businesses of what the Historic designation will mean. It is not restrictive in the sense of paint colors etc. but only a designation to help with funding opportunities.
- **D. Virginia Housing Stabilization Grant-** Funding to stabilize the back banks and parking behind Bailey-Robbins building, will take 3 months to complete the plan.
- E. Wastewater Treatment Plant Repair Grants- Brian covered these in his report above as he and Keith had met today with Mattern & Craig representatives doing onsite work. They will have a report in 2-4 months of how to move forward. On a question of I & I, Brian has also tried to get more information on the meter replacement for St. Charles from Lee Co. PSA. They only received one bid and with holidays and a member out for surgery, they look to prioritize the project in February.
- F. Water Treatment Plant Structural Repair Grants- is still awaiting ARPA funding.

In today's meeting, Keith and Brian reopened the sidewalk funding question with Mattern & Craig and walked the area from N. Main to the railroad with the idea of taking a sidewalk all the way down N. Main into Leeman Field. Estimated at \$5-10 million, M&C engineers think there is a pocket of potential federal funding, not at 100%, but possibly also have some Dept. of Transportation funding help. We must apply for it by February 28. We can possibly reuse the old bridge structure for crossing into Leeman and follow the river back to the greenway to connect. Another opportunity may be to finish the trail from the corner of Food City parking across to the highway and up to the caboose making a full circle connection with town.

- 12. **Town Attorney-**Greg reported the Planning Commission held a meeting last week but he was unable to attend and the Lee County EDA met with Pennington Town Manager, who spoke to them on some of the plans we have for town projects.

Virginia Code Section 2.2-3711(A)(5) Discussion concerning a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' or industry's interest in locating or expanding its facilities in the community.

Virginia Code Section 2.2-3711(A)(6) Discussion or consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the governmental unit would be adversely affected.
