- a) ARC Business Center/Conference Center-Keith has been in contact with Sen. Warner's office on funding through a Congressional Grant in the amount of \$1,000,000 with an 80/20 match. He also has contacted Morgan Griffith's office for a similar grant for the 20% match possibly.
- b) Industrial Revitalization Fund ARPA Grant Application- Keith signed contracts with the architect who estimated the asbestos abatement at \$45K. - c) Historic Designation- Hill Studio representatives will be here this week to catalog the Historic downtown buildings. The area includes from west at the old ODP/Flanary building (now Halos) east to the churches, south to the railroad and north to the Rescue Squad.
- **d)** Virginia Housing Stabilization Grant- Keith has signed the contract for work to begin April 20 and placed an advertisement for help to remove the old roof before then.
- e) Wastewater Treatment Plant Repair Grants- Brian said the project is approved for a VRA loan but the river crossing project was declined with DEQ ARPA funding. Only 23 of 183 projects were funded. We expect to hear from DEQ late May on whether they will forgive any debt. We

have 5 projects to apply for funding every 2 years up to 2032. Old terracotta pipe sewer lines need replacement along with many creek crossings, with short sections and lots of joints.

- f) Water Treatment Plant Structural Repair Grants-will require submitting a plan on the clear well to the health department to reduce the clear well.
- 12. **Town Attorney-**Greg reported taxing on the rescue squad was miscoded, he discussed with Lee County Commissioner and as a non-profit, it was not owed. We may need further clarification on alcoholic beverage tax if it is not sold with a meal as listed in our code.

13. Council Member reports:

All the council members welcomed Doug Alsup to the group. He will fulfill the rest of Mrs. Carson's term. Terry Pope asked that we consider a group of sponsors who will back some of the shows we have requests for, that if the show does not pay for itself, the group would then pay the loss.
